ALL RESIDENTS MUST HAVE A PARKING PERMIT ON YOUR VEHICLE AT ALL TIMES. IF YOU HAVE A RENTAL CAR, WE CAN GIVE YOU A TEMPORARY PERMIT IN THE LEASING OFFICE. IT IS \$50 TO REPLACE YOUR PARKING PERMIT.

ANY VEHICLE THAT IS DEEMED "IN NEED OF REPAIR" AND IMMOBILE OR HAS EXPIRED/UNREGISTERED TAGS IS SUBJECT TO TOWING.

I agree to place my permit in the front windshield in visible view (NOT IN THE TINT) of the vehicle it has been issued for. I will not move the permit to another vehicle. I will come to the office to have another permit issued for any new vehicles that I may get. I will not give this permit to anyone else to place on his or her vehicle. I agree that if I borrow any vehicle or purchase a new one, I will NOT park it on Property until I am issued a new permit for that vehicle from the Leasing Office.
